
Ri Online Mathematics Masterclasses are a series of workshops which are led by experts; University of Kent academics and guest lecturers will be speaking on topics in which they are at the forefront of current research. Masterclasses offer students in-depth investigations of topics in mathematics combining theory with interactive exploration. We will open their eyes to the world of maths and hope to inspire them to continue their engagement with the subject for a long time to come.

Enclosed is a flyer about masterclasses that can be shared with students, and a link to the online nomination form for you to complete. Please see below for more details and full instructions on how to get your students involved.

Students nominated should be in Year 12 in 2025/26 and should be aged 16-18. They should be judged to have interest in the classes and be studying Mathematics A-Level (or equivalent). We aim to challenge students who are well-motivated and curious about Mathematics and may well be inspired to carry on Mathematics to degree level. We are keen to reach students for whom other opportunities may not be readily available. They are required to join all three classes in a series. The University of Kent is strongly committed to equality, diversity and inclusivity and we encourage teachers to support this through their nominations. The Masterclasses will be delivered online via Zoom – participating students will need to be able to access Zoom for each session through a parent or carer's account.

How to nominate students

Select the right students

Students selected should be in Year 12 or Level 3 Year 1 in 2025/26, aged 16-18 years old, be judged to have interest in the classes and be studying Mathematics A-Level (or equivalent). Identify no more than five students who meet these criteria. The opportunity will be of particular interest to students considering further study in a mathematical subject.

Provide us with the details of the nominated students

- Seek parent/carer permission to nominate these students and to pass the parent/carer and student details to the Ri.
- Once you have the permission and details for all of the students, complete the below nomination form to provide us with this information:

- Complete and submit the form by 5pm on Thursday 29th January 2026.

What happens next?

Masterclasses are sometimes oversubscribed, so we cannot guarantee that all nominated students will gain a place. We will notify you on Friday 30th January to confirm places. We will also email the parent/carer directly with a link to a consent form that they will have to complete in order to secure their place. Those emails will be sent from MathsOutreach@kent.ac.uk.

How we use and manage your data

This activity is provided by the University of Kent and is designed to give you an insight into studying Mathematics at university, and to support you in your studies in Mathematics. We work in collaboration with other universities in Kent and Medway - Canterbury Christ Church University, The University for the Creative Arts and The University of Greenwich. Together, we fund the Kent and Medway Progression Federation (KMPF). We are all committed to helping students like you make decisions about your future.

What is personal data?

Personal data is information about you, like your name, where you live, what school you go to and when you were born. It also includes your views if we ask you to complete a survey.

Why are you collecting my personal data?

We would like to see you again and this will help us check if we do. We also use your data to explore if our activities make a difference to students like you. We think everyone should have a fair shot at going to university if they want to and our activities aim to help with that. To understand what happens to you after this activity, using your data we find out how you do in your A Levels/BTEC (or similar qualifications). We check if you decide to go to university. But do not worry, we are not just checking on you - we look at the info from lots of students together. Your name and personal details stay private.

If you disclose any medical condition or accessibility requirements this will be shared with the event staff in order to provide you with additional support and to ensure the event is accessible to all. This information will not be added to the HEAT database and will be deleted once the event has finished.

Will you share my data with anyone?

Your information will be kept in a database called HEAT, managed by a team at the University of Kent. They share your info with some other groups:

- The Office for Students (OfS - to meet our regulatory requirements)
- The Higher Education Statistics Agency (HESA - to see whether you go to university)
- The University and Colleges Admissions Service (UCAS - to see whether you apply to university)
- The Department for Education (DfE - to see how you did in your GCSEs and A level/BTEC or similar)
- Higher Education Access Tracker service subscribers (to make sure lots of different students are getting involved)
- The Kent and Medway Progression Federation (KMPF - to enable us to evaluate our work and ensure we are working with different students across Kent and Medway)
- The National Data Service (NDS - to see how you did in your GCSEs and A level/BTEC or similar)
- The Medical Schools Council (MSC) - for monitoring and evaluation of Medical School outreach delivery

Your data will be shared with the KMPF team and if you work with any of the partner universities, they will be able to see that you attended an activity with the University of Kent. For the activities

we run, we might need to tell your school/college that you joined in. But don't worry, we will only share basic details, like your name. This event is run in collaboration with The Royal Institution and we will share with them aggregated data on the number of students, adults and schools who take part. We will not share your personal data with The Royal Institution. The university and its partners will keep your data safe and not share it with anyone else.

Where is my data stored? Who can see it?

We keep your data safe on our computers. Only people who work for us or those we allow can see it.

How long will you keep my data?

Your data will be kept for a long time. If you have given us your first name, last name, date of birth and postcode then we will keep it for 15 years from the school year after you turn 18 in order to see whether you go to university in this time. If you decide you don't want your data kept or used during this time, just email us at dataprotection@kent.ac.uk and ask for it to be removed.

What are my rights?
