One Year On – Film Competition: Terms of Entry

This section is for competition entrants and outlines what the competition involves and what will happen to your work.

What does the competition involve?

The competition involves creating a short 10-minute film that conveys how life has changed in the year since the first lockdown, including the effects on the Arts sector. Completed films need to be uploaded to YouTube by the creators and a link to each film should be emailed to artshumsemployability@kent.ac.uk.

Films can be created independently or in teams of up to 4 people.

How will my work be used?

Entries will first be reviewed by the judging panel and shortlisted, after which the shortlisted videos will be shared on the Division's social media channels and audiences will be invited to vote on their favourite.

Winning entries may be embedded in a blog post on the School of Arts website.

What happens after the competition?

After voting has taken place, the judging panel will select their favourite film ('Judge's Choice'). The votes on social media will also be counted and a winner will be named ('People's Choice'). Each winning film will be awarded £100 in Amazon gift cards. It will be up to the winning participants to decide how to split the gift card total. No cash equivalent will be offered.

What happens to the copyright in my work?

You will retain the copyright in your film and as part of the terms of use you agree to license it under a Creative Commons 'Attribution-NonCommercial-NoDerivatives' licence. This licence allows others to download and share your film as long as you are credited as the author. However, your work cannot be changed by others in any way or used commercially. You must ensure that you have the necessary permissions from anyone appearing in your film by getting them to complete the participant release form (p.2).

What is the purpose of this filming?

Filming is being undertaken for the purpose of producing a short film, which will be submitted as a competition entry to the Arts and Humanities Employability and Placements Officer. The exact content of the filming will be determined by the participant(s).

Full details regarding the competition are outlined in the 'Terms of Entry' on Page 1.

What will the footage be used for?

The footage will be used to create a short film that will be uploaded to YouTube by the filmmaker. The completed video will then be reviewed by the judging panel.

The panel will review all submissions and select a shortlist of the best entries. The shortlisted videos will be shared on the Division's social media channels and audiences will be invited to vote on their favourite.

All videos will be made available under a Creative Commons 'Attribution-NonCommercial-NoDerivatives' licence which means the video can be shared online, but cannot be used for commercial purposes or adapted to create new works. Where will the footage be available to view?

The raw footage will be stored by the filmmaker(s), who is/are ultimately responsible for its safe-keeping and eventual disposal. The finished videos will be uploaded to YouTube, from where they may be embedded on social media posts from the Divisional accounts (Instagram, LinkedIn, Facebook, Twitter). Winning entries may be embedded in a blog post on the School of Arts website.
