



WORKSHOP ANNOUNCEMENT — CITIZENS AND INCLUSIVE GOVERNANCE

This Friday, the 7th February 2020, the Conflict Analysis Research Centre (CARC) will host the workshop on Citizens and Inclusive Governance as a programme addition to the annual John Burton Lecture series.

This two-day event kicks-off with a talk by Professor Caroline Hartzell from Gettysburg College on the 6th February entitled "Parsing the Peace: Citizens in Civil War Peace Processes".

Professor Hartzell will discuss the role of civic engagement in peace processes beyond traditional "elite actor" involvement and guide the audience towards intricate and informed insights concerning the interplay between peace agreements, citizen involvement and power sharing.

The insights of the John Burton Lecture concerning citizen-led peacebuilding and power sharing will be broadened and deepened during the complementary workshop "On Citizens and Inclusive Governance" which will take place on February 7th.

This workshop will cover various facets of power-sharing, critical citizen involvement and peacebuilding processes. It is devoted to presenting current and evidence-based research by a delegation of leading researchers and policymakers. It will combine research presentations, book presentations and panel discussions, as well as short films. Attendees of this event will have an opportunity to discuss recent trends in conflict related as well as governance research and to contribute to global academic discussions. The workshop is funded by the US Institute of Peace (USIP) grant Citizen Engagement in Peace Processes.
